Support Scheme for Publication Fees

APPLICATION

Criteria

- a) Applicants should be citizens of Sri Lanka and registered with the STMIS database of the NSF.
- b) Applicants should be either the first author or a corresponding author of the Research Article.
- c) Publications should arise in an Open Access journal indexed in the Clarivate Analytics Science Citation Index Expanded (SCIE) or Social Science Citation Index (SSCI).
- d) To be eligible for consideration for a grant, the Journal should have a **Minimum Impact Factor of 2.0 (for SCIE Journals) or 1.0 (for SSCI Journals)**, according to the Journal Citation Report of Clarivate Analytics for the year the article is published.
- e) The article should be published in or after January 2023.
- e) Applicant should be affiliated to a State University/Institution.

NOTE: This scheme operates on **reimbursement basis. Only the publication fees are supported, bank charges and taxes are not included.**
